John G. C. Miller Scholarship

A Regent University alumnus, who is a quadriplegic, established the John G. C. Miller Scholarship fund to honor her father. The goal of this scholarship is to assist other Regent students who have physical disabilities in meeting the tuition costs of attending Regent University.

The awards made from this fund are highly selective and the number, as well as the dollar amount of the awards, are limited and vary each year, depending upon the performance of the fund. Awards are made for one academic year at a time, with the award being effective beginning in the fall semester through the following summer term(s). To retain the award from one semester to the next, the student must maintain at least the minimum appropriate grade point average each term as defined in the University catalog as necessary to avoid being placed upon academic probation.

Awards offered are based upon a projected enrollment of at least six (6) credit hours per term in one of Regent's graduate or professional degree programs. If there is a variance from these projections, the award is subject to cancellation. Exceptions may be made to this projection of enrollment hours if it is the student's final term of enrollment where less than six credits are needed to graduate. More details will be provided to awardees when notified of selection.

Students must reapply each year. An application is required to be submitted each year by the published deadline for consideration of an award in a subsequent year. Previous recipients are not guaranteed renewal from one year to the next.

Application procedures:

1. Answer the application questions listed on the reverse of this form on a separate sheet of paper, not to exceed one page per question. You must be accepted for admission by **5:00 pm (Eastern Standard Time) on March 1, 2012** for the **2012 - 2013** academic year to be eligible.
2. You must have registered your disability with Regent University's Office of Student Services in SC 201, 757-226-4103.
3. Submit the completed application to Central Financial Aid by **March 1, 2012 5:00 pm EST.**
4. All application materials must be **received** by the Central Financial Aid Office by **5:00 p.m. EST on March 1, 2012** for consideration. All application materials must be mailed to the following address:

Applications submitted to any address and not received by the deadline may not be considered.

5. *Faxed applications will not be considered.*
6. **You must reapply each year.** Previous recipients are not guaranteed automatic renewal.
7. A Scholarship Committee composed of University faculty and staff selects recipients.
8. Some students may be contacted for an interview as part of the selection process.
9. Applicants who submit their applications by the deadline should receive notification by mid-May.

Although not required for this scholarship, letters of recommendation from your pastor/priest and previous faculty members may add weight to your application's consideration. If you choose to submit these, there should not be more than a total of three (3) and they must be submitted with the application. Letters of recommendation from pastors/priests must be on official church letterhead.
