- Broad responsibility for library access services, contents and resources management, reference and instructional services. Directly supervise Head of Access Services, Head of Contents and Resource Management, Head of Reference and Head of Library Instruction.
- Responsible for development and implementation of policies and procedures; facilities and maintenance issues; internal and external communications and all personnel administration.
- Actively involved with library budgetary processes, financial reporting, oversight of library expenditures and fundraising activities.
- Manage all assessment activities in the library, including chairing the Assessment Team and coordinating LibQUAL+.
- Actively involved with Library strategic planning and regional accreditation activities. Work in close collaboration with the Director of Libraries on the development of an Internet Café, Information Commons, Media Center, and other special projects.
