Featured Database. . . HeinOnline

The HeinOnline database includes four major collections: the Law Journal Library, the Federal Register Library, the Treaties and Agreements Library, and the U.S. Supreme Court Library. All of these libraries are image-based and fully-searchable, meaning that they provide exact page images and enable the researcher to view all pages as they originally appeared in hardcopy—including all charts, graphs, and photographs

- ***HeinOnline Law Journal Library***

The HeinOnline Law Journal Library provides full-text access to a substantial collection of law reviews and legal journals. Coverage begins with the first volume of the periodical, proving an excellent source for locating older articles. Documents may be located by citation, author and title, or by browsing. This database is particularly useful for law review and journal members working on cite-checks, professors, and other researchers who need to access original sources.

- ***HeinOnline Federal Register Library***

The Federal Register Library provides both OCR text and PDF images of the content of volumes 1-70 of the *Federal Register*, as well as *Federal Register Indexes* (1939-1995); *Compilations of Sections Affected* (1949-2000); and the *Weekly Compilation of Presidential Documents* (1965-

2004). Documents can be located by citation, by date, by keyword, or by browsing.

- ***Treaties and Agreements Library***

The HeinOnline Treaties and Agreements Library includes both OCR text and PDF images of the content of *International Legal Materials*; *KAV Agreements*; *Treaties and International Act Series* (TIAS); *Treaties and Other International Agreements of the United States of America 1776-1949*; *Treaties in Force and Guide to Treaties in Force*; and *United States Treaties and Other International Agreements*. Treaties and other documents can be located by citation, by date, by keyword, or by browsing.

- ***HeinOnline U.S. Supreme Court Library***

The HeinOnline U.S. Supreme Court Library includes both OCR text and PDF images of cases published in the *U.S. Reports*, as well as more recent slip opinions. Content includes *U.S. Reports* (1754-2003); *U.S. Reports Preliminary Prints* (2002-2004); and *U.S. Reports Slip Opinions* (2002-date). Cases can be located by citation, by case name, by keyword, or by browsing.

Help! The Law Library Doesn't Own the Book I Need!

The Law Library offers an extensive array of print and electronic resources. Chances are, we do have what you need. If you have trouble locating a particular resources, contact a Research Services Librarian for assistance.

If the material you need is not available through either the Law Library or the University Library, there are two ways to get what you need.

The Tidewater Consortium. Regent University is a member of the Virginia Tidewater Consortium, an association of 15 local colleges and universities which have entered into a reciprocal agreement

for sharing resources, including library materials. Regent students may borrow books at any member library with a valid student ID and a consortium card. To get your consortium card, just visit the Law Library's Access Services Desk during regular business hours.


Interlibrary Loan (ILL). To request material, you may obtain an Interlibrary Loan (ILL) form from Access Services or submit an [online request](#). First-time users of the online interface must complete the registration process, which includes creation of a personalized user name and password.

The Law Library has a new, totally electronic ILL System! You MUST register as a new user before your ILL requests can be processed.

Registration is easy and only takes a few moments. The form is available at: <http://illiad.regent.edu/illiad/LAWILL/illiad.dll> ID # refers to your Regent University student ID number, located on the front of your Regent student ID badge. Once you have complete the registration process, you will be able to submit your ILL requests electronically!
